## Description

**Course Description:** This Independent Study is an opportunity for Legal Studies graduate students to pursue an independent research project under the mentorship and discretion of a faculty member. The course requires a major research paper; there will be no examination. Students will submit a request to take the independent study to the Registrar and will include the name of a faculty with whom they have coordinated. Prior to registering, students should first contact the professor with whom they wish to mentor their independent study, coordinate an agreement on the grading requirements, and then NOTIFY their academic advisor with the name of their professor. The final approval to take the independent study will be made by the Program Director.

### Course Scope:

The purpose and scope of this course is to provide graduate students the opportunity to do independently work in a specialized area of Legal Studies not covered by course offerings. The student will complete an approved research paper that demonstrates mastery of their program of study in a meaningful culmination of their learning and assess their level of mastery of the stated outcomes of their degree requirements.

All courses in the Legal Studies program require that any narrative essay or composition format follow the legal citation guidelines set forth in The Bluebook: A Uniform System of Citation.
